



Resolution for Cleaning up Voter Rolls

WHEREAS, the voter rolls in many states, including Georgia, are terribly inaccurate with tens of thousands (if not more) of voter registrations for people who do not exist, do not live in the county, or who do not have valid addresses in the county in which they are registered to vote;

WHEREAS, actions to prevent ballot fraud will be ineffectual if the [voter rolls are not accurate](#) and up to date;

WHEREAS, [experts on election integrity are predicting](#) that Democrats in 2024 will follow their past practices to mail in ballots that are illegally cast in the name of people who have invalid voter registrations;

WHEREAS, to date actions in Cobb County to clean up voter rolls have been ineffectual because of the resistance of the majority of the County Board of Elections who were selected by Democrats;

WHEREAS, the Georgia Secretary of State participates in the Electronic Registration Information Center (“ERIC”), [an organization started by David Becker \(a Left wing Democrat\) who has used ERIC](#) to collaborate with the Center for Election Innovation and Research (“CEIR”); and CEIR was one of the two leftist groups to use Mark Zuckerberg’s \$419 million to fund the private takeover of government election offices in 2020;

WHEREAS, in the past year [seven Republican led States have resigned from ERIC](#) because of the organization’s suspect practices that do little to protect the integrity of voter rolls;

WHEREAS, if litigation is necessary to clean up voter rolls before the 2024 election, it must be started in the next few months and is likely to be expensive;

WHEREAS, the individual county Republican parties in Georgia do not currently have the resources to take action, including lawsuits, to successfully challenge corrupted voter rolls in each county;

WHEREAS, the [Secretary of State of Georgia has shown little or no interest](#) in protecting the integrity of voter rolls in Georgia or in investigating questionable practices in the 2020 Presidential Election;

THEREFORE, the Cobb County Republican Party hereby resolves that:

1. The Cobb County delegation to the Republican Party 2023 State Convention is instructed to press the issue of the desperate need for effective action to clean up the voter rolls prior to the 2024 General Election with appropriate resolutions to commit the Georgia Republican Party to such action.

2. The Chairman of the Cobb County Republican Party is instructed to send a letter to both the Governor and the Secretary of State to demand that they join other Republican led States in leaving ERIC.

3. The Chairman of the Cobb County Republican Party shall take the opportunity afforded by the 2023 State Convention to discuss with other county party leaders voter roll cleanup efforts throughout Georgia, which may include litigation to enforce voter roll challenges and fund-raising efforts for the costs of such litigation. Fund-raising may include enlisting the Georgia GOP and the national GOP.

4. In preparation for effective action to clean up the voter rolls the Chairman of the Cobb County Republican Party shall designate party officers and members that she selects to identify and contact [election integrity groups](#) who can assist in the effort to clean up the voter rolls in Georgia. They shall report back to the Chairman as to the results of that research no later than June 16, 2023.
